RELEASE AND AUTHORIZATION

Rules & Regulations:

- Couples must dance in the age category of the eldest partner & may dance up one age level.
- Entries must be made on the San Diego Dancesport Championships entry forms.
- Names of both partners must be listed for entry to be accepted.
- Parents will not be permitted in or around the line-up area.
- No changes will be made at the event unless it is our mistake!
- All events will be run even if couples are late or not present, no event will be repeated.
- Children are expected to be on their best behavior while attending the competition. They are NOT permitted to run or play in the ballroom or the hotel in general.
- Any complaints about a child will result in the child being prohibited from dancing and evicted from the ballroom. No refunds will be made under these circumstances.
- Video permits are available for \$20 per camera. You must put the permit on the camera. (No standing tripods, hand held cameras only)
- Dress Code, appropriate costumes are required, sexy, see through, or revealing costumes will not be tolerated. The Organizer will determine the standard of the dress. Anyone not adhering to the dress code will not be allowed to dance, or will be disqualified if they dance and no refunds will be given for entry fees, tickets, etc.
- Due to the high volume of entries and administrative work, there are no refunds.

RELEASE AND INDEMNIFICATION:

Participant hereby forever releases and discharges San Diego Dancesport LLC., its officers, directors, shareholders as well as any person, employee, subsidiary, affiliate, party, or business entity that is affiliated with, sponsors or organizes "The San Diego Dancesport Championship" ("Event Organizers") from liability for the following: (1) loss or theft of articles left in Changing Rooms, the Ballroom, or Hotel Rooms; (2) injuries sustained by any participant or any other person attending this event and Participant acknowledges that (s)he attends this event at his/her own risk; (3) any liability or claims arising from the production, exhibition, transmission, distribution or use of commercial material authorized in this Agreement; and (4) any claims, demands, suits and actions which Participant ever had, now has, or may have based upon any agreements previously made or herein made. Participant shall defend, indemnify and hold Event Organizers harmless from and against any and all claims, demands, losses, suits and expenses relating to this Release and Authorization arising out of Participant's actions or negligence.

AGREEMENT REGARDING RULES AND REGULATIONS:

Participant agrees that he/she and all persons attending this event with Participant, whether as spectators, competitors, officials or guests are obligated to adhere to the "Official Rules." A copy of the Official Rules shall be available to Participant in the competition package or may be obtained from the registrar.

CANCELLATION/REFUND POLICY

The deadline for a refund on a cancellation is 30 days prior to the date the competition commences. Refunds will

be made by mail, 30 days following the completion of the competition. If the Organizer is notified of cancellations after the deadline, credit toward the following year will be considered in cases of emergency only and must accompany a Doctor's Certificate. There will be a minimum \$50 service charge, per participant, for cancellations.

No substitutions will be allowed for entry cancellations at the event. No exchanges or refunds will be made on admission tickets. (ALL TICKET SALES ARE FINAL)

AUTHORIZATION FOR USE OF PARTICIPANT'S IMAGE FOR COMMERCIAL GAIN:

Participant hereby irrevocably grants to San Diego Dancesport LLC, the sole and exclusive right to use, refer to and reproduce programs by means of video tape recording or any other method of media reproduction, hereinafter referred to as "reproductions." All copyrights created relating to reproductions in which Participant's name, likeness, image, voice, and/or performance is featured, shall be the sole and exclusive property of Event Organizers. Participant waives any right to copyright enforcement and protection regarding any reproduction which includes any aspect of Participant or Participant's performance.
